This Waiver and Release is given in exchange for the permit and for the use of the facility designated herein. The undersigned agrees and as agent for the entity using the facility below promises and covenants not to sue the Civil Town of Mooresville or the Mooresville Park & Recreation District, its agents, servants or employees for any damages, injuries or any other cause of action related to this Agreement or the facility designated in this Agreement.
